#### NOTIFICATION

The post of Assistant Auditor (32 vacancies) and the post of Junior Divisional Accountant (24 vacancies) advertised by the Commission vide No. MPSC/ADVT-38/1/2012-2013/75 dated 14<sup>th</sup> January, 2013 and No. MPSC/ADVT-38/1/2012-2013/13 dated 1<sup>st</sup> July, 2013 respectively, carry identical pay scale/eligibility criteria. The syllabus prescribed for the open competitive examination in respect of both the posts is also identical. The Commission, after careful consideration of these facts and taking into account the substantial number of candidates and with a view to ensure completion of the selection process within the shortest possible time, is satisfied that it is appropriate and necessary to combine the recruitments arising out of the aforesaid advertisements. Accordingly, the Commission has decided that there shall be a combined recruitment for the above said notified vacancies which shall run through the following stages:

### 1. Preliminary Multiple Choice OMR based screening test on:

- a. General English 100 marks,
- b. General Knowledge 100 marks,
- c. Aptitude Test including Arithmetic 100 marks.

## 2. Conventional Essay type Examination on subjects as specified in the syllabus viz.

- i. Paper I Essay and Précis Writing 100 marks, Current Degree
- ii. Paper II General Knowledge 100 marks, Standard
- iii. Paper III Arithmetic 100 marks (SSLC Standard)

#### 3. Personal Interview

On the basis of the screening test, the number of candidates who shall be declared qualified by the Commission to proceed to the next stage viz.. Conventional Examination, shall not be more than ten times the number of vacancies.

On the basis of the conventional essay type examination, the number of candidates who shall be declared qualified to appear for the Personal Interview shall not be more than three times the number of vacancies.

Candidates, who have applied for both the posts, if they qualify for the Personal Interview, shall be allowed to exercise their option for the posts in order of preference.
